

For 18 years I've been in front of the Foundation for the Future of Colombia (COLFUTURO). In those almost two decades, many things have changed in the country and in the Foundation.

Few foreign citizens used to come to Colombia. Apart from being a dangerous country to visit, it was not very interesting in the context of international education. How different the current situation is! While in the year 2000 just a little more than 500,000 persons visited the country, last year was a record: more than three million.

On the side of COLFUTURO things have also been very different: in the year 2000 we selected 92 individuals, out of which 75 successfully carried out their studies abroad. On mat 15 of 2019 we culminated the most competed selection process in the history of the Foundation: we received 3,094 applications, out of which we chose 1,364 persons that are going to course master's and doctorate programs in the most prestigious universities in the world.

This is the tenth consecutive time in which we get to choose a thousand or more beneficiaries per year. In this Digital selection yearbook 2019 we want to celebrate such achievement, for we are conscious how important it is for the country to maintain an initiative that connects thousands of the best minds in the country with post-graduate education opportunities in the main universities of the world.

The first value of COLFUTURO is transparency. For such reason, in this book we used to include the complete list of each one of the selected individuals, as well as a brief profile them. Such list has become so extensive, that putting it in a printed version no longer makes sense. Therefore, I invite you to visit **www.colfuturo.org/apps/seleccionados2019** in order to see the list, filter it, look at it by region of origin or university of destination, and pleasingly study it for what it means to Colombia.

In accordance to that very spirit of transparency, in this publication you will find the names of our donors, and the amounts donated thereby; you will know who are the members of our Board of Directors and the staff; the persons that this year composed the area committee, to whom we send special gratitude for their sustained effort, and, of course, the professionals that permanently conform the Academic Committee, as well as the list of agreements in place, organized by country. Furthermore, a graphic is included, which shows in detail how we make our selection in order to guarantee equality, anonymity, and in order to offer the same opportunity to all candidates.

In COLFUTURO we have the deep belief that "we are what we do and what we achieve", and for this reason a significant part of this book includes all our statistics and metrics. We have worked in order to make them interesting, easy to read, and in order for them to tell a story and to generate reflections.

In summary, inasmuch as COLFUTURO exists to serve its beneficiaries, this Digital yearbook was created in order for you to be very well informed on what we do.

History of COLFUTURO

Under the leadership of Ana Milena Muñoz de Gaviria, the Fundación para el Futuro de Colombia (COLFUTURO) (in English: the Foundation for the Future of Colombia) was established in 1991, thanks to the initiative of a group of wealthy citizens of the public and private sectors, committed with the development of the country through its human capital.

COLFUTURO has consolidated in Colombia as a leading institution in the financing of postgraduate studies abroad. Its model has been successfully copied, with the direct and committed support of the Foundation, in Guatemala with Guatefuturo, Honduras, with Hondufuturo and in Mexico with Educafin and Funed.


Since 2011, COLFUTURO started offering to third-party institutions its experience in financial management


of external programs and in the development of a robust and complete technological platform that enables the administration of summoning and selection processes, program-rating, student management, cash disbursements and educational support project collection management.

The Sponsor-credit Program (PCB for its acronym in Spanish) has disbursed, until class of 2018, USD 327 million, and has USD 20 million yet to be disbursed. During this promotion stage, USD 55 million will be granted as aids, for a total USD 402 million in aids for its beneficiaries.

In addition, it has committed USD 157 million in debt relief, from which USD 13 million correspond to COLFUTURO funds and USD 144 million are Colciencias funds.

Sponsor-Credit Program

Sponsor-Credit Program

This is the main program of COLFUTURO. It was created with the aim that the most talented Colombian citizens can access postgraduate education in the most recognized universities in the international stage. Thanks to this program, students can request a loan for a maximum of USD 50,000 for up to two years, in order to finance their postgraduate education.

As from 2017, the maximum percentage of debt waiver may reach up to 80% of the value of the sponsor credit. The percentages of the sponsor depend on the decisions that the beneficiaries take, as follows: 20% of the capital for programs on Management and Law, and 40% for all the doctorate degrees and other areas. Additionally, 20% for those persons that work out of Bogotá for three years, or 20% for those who work on the public sector or academia for three years. Said percentages of debt waiver are cumulative, for which the sponsor component may reach 80%.

In the framework of this program, unique in Colombia, a rigorous selection process has been developed, in which the criteria for selection is the academic excellence of the nominee and of the chosen program. To this date, 28 promotions of students that have represented Colombia in the most prestigious universities worldwide have been selected. The experience and integrity with which COLFUTURO has assumed the selection process and general management of the Sponsor-Credit Program (PCB, for its acronym in Spanish) has consolidated this support model as a leading initiative in Colombia and Central America.

Support of the National Government

In 2007, the first cooperation agreement between the National Ministry of Education, the Colombian Institute of Education Credit and Foreign Technical Studies (Icetex, for its acronym in Spanish) and COLFUTURO, was signed. One year later, this agreement was extended by Colciencias, Icetex, and COLFUTURO.

For March 2009, it was determined that the national Government would assume, for at least nine years, the resources corresponding to the debt waiver (sponsor) that is given to the selected professionals in the Sponsor-Credit Program.

In 2017, through the National Council of Economic and Social Policy (Conpes, for its acronym in Spanish) 3862 of 2016, that amended Conpes 3835 of 2015, the new schema of debt waivers for the Sponsor-Credit Program was established, and the Government agreed to contribute COP 698,000 million to support the growth of COLFUTURO until the year 2025.

Talent Seeding

This program has the purpose of promoting a greater participation of candidates with academic excellence in COLFUTURO summons, specifically, those from public universities.

The summons are made per year, in order to identify the future seedings. The process for the election of the candidates of the Talent Seeding is highly rigorous and is focused on academic excellence and in the leadership qualities of the candidate, considering criteria such as the position held in the undergraduate program and the grade point aggregate, among other academic merits and acknowledgements.

The experience of COLFUTURO has shown that the main reasons why many of the most brilliant professionals of the country refrain from starting postgraduate studies is the lack of domain of a foreign language, the lack of knowledge on how to choose a university of academic excellence and the belief that it is impossible to finance the costs of living and studying abroad. The Talent Seeding Program directly works on solving these problems through personalized assistance and advice that includes several tools, such as counseling, workshops, informative sessions, ratings of the postgraduate programs, review of application essays and requirements, and a technological tool. The assistance process is provided for a period of up to three years.

COLFUTURO, through the Seeding, has set the goal to strengthen areas such as Engineering, Health Sciences, Basic Sciences, Economy, Social Sciences, Education, Arts and Agricultural Sciences and Environment.

The Talent Seeding has been operating for nine years, and currently has 1.100 participants. These are last grade undergraduate students and professionals who have just graduated, who have obtained an average above 10% of their classes, who make part of an investigation group certified by Colciencias, have obtained an Ecaes above 5% or have obtained the *summa cum laude* merit or have graduated with honors.

Consejería Académica

This area of COLFUTURO is the entry door for Colombian professionals who wish to complete postgraduate studies abroad. Its main objectives are:

- ★ Guide and provide assistance to persons interested in completing masters or doctorate degrees abroad, in order to enable them to choose high-quality programs that meet their corresponding personal and professional expectations.
- ★ Throughout the year, collect serious and independent information that enables the analysis, assessment and ranking of the universities and the postgraduate programs offered throughout the world, with the purpose of providing academic counseling to the interested parties.
- ★ Study and assess the masters and doctorate programs of the candidates to the Sponsor-Credit Program, based on international rankings, accreditations and other publications on postgraduate education.

- ★ Negotiate and administer cooperation agreements with universities and other institutions that offer our beneficiaries the best opportunities for them to course their postgraduate studies.
- ★ Participate in international education fairs, conferences and events, with the purpose of spreading the word of the work made by COLFUTURO, and to promote postgraduate education abroad.
- ★ Constantly update the official website with diverse and useful material on postgraduate studies abroad.

Languages

The COLFUTURO Languages Program has the main purpose to promote the learning or improvement of a second language (English, French or German) among the Colombian students and professionals.


The main benefits offered by the program are:

Improving the language domain in universities of 8 countries: Australia, Canada, United States, Malta, New Zeeland, United Kingdom, France and Germany. The student determines the duration and destination of his/her program within the 27 cooperation agreements that are currently in place with COLFUTURO.

A percentage of discount is offered on the price of the course, which ranges between 10% and 55%, depending on the university elected by the student. The amount of the discount is already established in the agreement with each university.

 Assistance is provided during the process of admissions to the university of destination.

- The election process is mainly focused on the motivation and the complete fillingin of the online form by the aspiring students.
- Assistance is provided for the visa process, depending on the country.
- Throughout the year, scholarships for the total amount of the course are granted to certain students that are interested in the program, as well as to outstanding participants of the Talen Seeding Program. These scholarships are offered by the universities.
- 4 summons are made, in which more than 400 persons interested in completing an English, French or Cerman course abroad participate.

Networks, Employment and Entrepreneurship

The Network, Employment and Entrepreneurship Program has the purpose of providing assistance to the beneficiaries in the construction of a valuable network of contacts that will enable them to materialize their labor and entrepreneur project.

In order to meet this purpose, three lines of action are specifically addressed: labor projection, networking spaces and strengthening of entrepreneurship.

Labor Projection

- Creating strategic alliances with companies and entities from all sectors and based on the needs, so as to increase labor opportunities.
- Development and implementation of tools and spaces that enable visibility, and connecting the beneficiaries with the companies and labor offers.
- Creating interactive spaces for the structuring of their labor project: resume, interview and work search.

Networking spaces

 Structuring and development of spaces for the interaction and transfer of knowledge, aligned with the areas of COLFUTURO, the interests and needs of the beneficiaries and the matters that are relevant for the country.

Strengthening entrepreneurship

- Ceneration of alliances with the national and international entrepreneur ecosystem, in order to increase knowledge and facilitate the projection, structuring, visibility and coming together of sources for the financing of the entrepreneur projects of the beneficiaries.
- These strategies, alliances, technological initiatives, spaces for knowledge, articulation and interaction, seek the strengthening of the COLFUTURO Network into a network with more and better opportunities for the beneficiaries.
- The articulation of lines of actions has been strengthened through Enlace, an exclusive network for the beneficiaries that currently has more than 3.300 professionals connected with opportunities, knowledge, events and projects.

With the purpose of multiplying each dollar given by COLFUTURO to its beneficiaries, cooperation agreements are constantly executed with national entities, universities and representatives of international governments, that grant our students full or partial scholarships in tuition fees and other financial aids.

We have 5 national agreements and 105 with institutions in 17 countries, all in the areas of knowledge.

National Agreements

Proimagenes Colombia

The Consejo Nacional de las Artes y la Cultura en Cinematografía (CNACC) supports, since 2011, those who study abroad postgraduate programs related with the audiovisual industry. The resources invested per year originate from the Fondo para el Desarrollo Cinematográfico (FDC) and are administered by Proimagenes Colombia.

The beneficiaries of COLFUTURO who complete their programs in matters related with the audiovisual industry can have a 45% scholarship, in addition to the one granted by the Foundation. The CNACC determines the beneficiary based on the resources available each year.

As part of this agreement, professionals of the audiovisual areas who meet the required academic requisites can form part of the Talent Seeding of COLFUTURO. There, they will receive advice and guidance throughout the application process of a first-level postgraduate program, and with specific activities of interest in their areas.

Embassy of France

Currently, COLFUTURO and the Embassy of France have three lines of support:

- Support to seeding.
- Embassy of France CEF.
- Embassy of France Doctorate Formation.

Support to seeding

The participants of the Talent Seeding Program elected by the Embassy of France have access to 400 hours of training in the French Language in the regional premises of the Alianza Colombo Francesa, as preparation for the postgraduate studies in France. In addition, they receive a 25% discount in the rates of Campus France, an entity that administers the admissions to French education centers, and completes the proceedings to obtain the student visas.



Embassy of France - CEF


The Embassy of France, the Corporación para los Estudios en Francia (CEF) and COLFUTURO executed an agreement that benefits Colombian professionals who course masters or doctorate studies in France during the 2018-2019 period.

The Embassy of France and the CEF, entity responsible to promote and facilitate the formation of young Colombians in the best universities in France, will destine $\epsilon_{120.000}$ per year, during four years, and such resources will be administered by COLFUTURO. It is estimated that 30 students elected for the Sponsor-Credit Program will be supported with $\epsilon_{4.000}$ each, which amount will be contributed to the student's loan with COLFUTURO, once he/she returns to the country and meets the rules of PCB.

Embassy of France Doctorate Formation

The Embassy of France and COLFUTURO executed an agreement that benefits Colombian professionals who have coursed doctorate studies in France, with the support of the Sponsor-Credit Program, and who are in their first year stay in the country.

The Embassy of France will destine 30.000 per year to this plan, and such resources will be administered by COLFUTURO. It is estimated that ten students elected for the Sponsor-Credit Program will be supported with \in 3.000 each, which amount will be contributed to the student's loan with COLFUTURO, once he/she returns to the country and meets the rules of PCB.





International Agreements

Harvard University

With this agreement, COLFUTURO and Harvard University jointly sponsor up to five doctorate students and up to fifteen masters' degree student per academic year.

COLFUTURO offers standard support to the master's degree students, and Harvard supplements it until it reaches the additional required costs. For such purpose, it mobilizes the resources of Fondo Colombia-Harvard and other funds.

COLFUTURO offers support to doctorate students for up to two years and maximum USD50.000. In turn, Harvard supplements the support provided by COLFUTURO and secures the resources from other sources in order to meet the entire cost of the doctorate, both for tuition as well as for living expenses, which constitute the scholarship.

The beneficiaries not elected by Ayudar Scholarships will receive a 20 % in the tuition fees.

Thanks to this agreement, the master's and doctorate students who go to Germany receive in Colombia a course of German with a maximum duration of three months (only in the events of Human Sciences, Law, Economy and similar sciences), and other in Germany, of up to six months, prior to starting their students.

In addition, the students have all the benefits of the DAAD grantees in Germany,

including, a health insurance and a thirdparty damage insurance (covering them and their dependents), as well as the cost of the flight tickets between Germany and Colombia. DAAD supplements the support provided by COLFUTURO in several items.

25 % discount in tuition fees for five COLFUTURO beneficiaries, for a term of two years for master's degree students, and of three years for doctorate students.

By means of this agreement, full scholarships are granted to maximum five students per year in the doctorate programs, and with partial scholarships to maximum fifteen master's students admitted by the university and selected by COLFUTURO.

Hult International Business School

Hult offers to partial 50% scholarships: one for an MBA program and the other one for master's programs. In addition, it will grant six partial 20% scholarships to the rest of the students admitted to any master program and selected by COLFUTURO.

New York Film Academy (NYFA)

NYFA offers a USD 10.000 scholarship in tuition fees per each year of study for all COLFUTURO beneficiaries in the MFA Filmmaking, Acting for Film, Producing, Screenwriting, Photography, Documentary, Cinematography and Game Design; or MA Filmmaking & Media Production.

New York University - NYU Tandon School of Engineering

NYU Tandon School of Engineering offers 25 scholarships for 40 % of the tuition fees, plus a USD 2.000 aid for 200 hours of work, for COLFUTURO beneficiaries admitted in programs of this faculty.

North Carolina State University

Three scholarships for the amount of the difference between the *in-state and out-state student* tuition fees. COLFUTURO beneficiaries shall pay the in-state tuition fees (in-state makes reference to the amount of the tuition fees paid by a student in the State of North Carolina, which is substantially less than the one paid by an international student).

50 % discount in tuition fees for a maximum of four COLFUTURO beneficiaries admitted in the MBA program.

Ohio State University - Moritz College of Law

50 % discount in tuition fees for all COLFUTURO beneficiaries admitted to the LL.M. program.

Purdue University

Latin American Technical, Research and Administrative Leaders Program (LATERAL) shall grant a discount of more than 35 % of the total tuition fees of their programs. The student shall pay approximately USD 66.000 instead of USD 97.000. This agreement is addressed towards the students who conduct the investigation on LATERAL, and provides for additional benefits that are listed in the agreement.

Purdue University - The Krannert School of Management

A Graduate Assistantship is granted for maximum four COLFUTURO beneficiaries admitted to the full time MBA program. In exchange, the beneficiaries shall render services in each one of their disciplines, according to the availability and hours required by the institution.

The beneficiary shall receive an aid and a discount equal to almost 50 % of the tuition fees per year. The aid can be extended according to the academic results of the beneficiary.




